BRANDING GUIDELINES

CYBER ESSENTIALS BRAND BADGE

The badges will be used as the primary identifier for the Cyber Essentials scheme. Consistent application of this brand identity will strengthen the scheme identity.

The Cyber Essentials Badge can only be used by organisations that have passed the relevant assessment.

The badge will be issued to successful companies by their Certification Body. It will be the responsibility of the Certification Body to ensure that the Badge is used in accordance with the certification and these guidelines.

Badges

There are two levels of Badge, Cyber Essentials and Cyber Essentials PLUS. Cyber Essentials will be awarded to organisations gaining tier 1 certification and PLUS to those attaining tier 2.

Validity of the Badge

The Badge is only valid if it is displayed in accordance with these guidelines

Use of the Badge

The Badge can be used by authorise organisations on:

- Websites
- Promotional Material
- Letter Heads
- Email Signatures

in line with the guidance contained in this Appendix

Use on Websites and Email Signatures

When the badge is used on websites or email signatures it should be protected against unauthorised copying


Minimum Clear Space Requirements

The minimum clear space surrounding the badge should be equal to two letter 'C' in Cyber Essentials. This will ensure that the badge is easily identified.



Minimum Reproduction Size

The minimum reproduction size of the badge is 26.1 mm in length by 22mm high



Background

The Cyber Essentials colour Badge should always be displayed on a plain white background

Or






Do not stretch or distort
